Budget Committee- preliminary report

- Budget will be increased by 3% to 4 % next year depending on the strategic plan and what services will be implemented.
- Update of making network services mobile- responsive catalog, Enterprise will be mobile friendly by January 2015.

- Bookmyne: Individual libraries may have their own branding, through blue cloud morning.
- Boopsie: app very expensive 19,000 per year for network
- Capira Startup company with a development connection with Sirsi. Approximately 600 per library. Update date 2500 license fee. One time cost 300.
- Chromebooks are being investigated for use by patrons and library staff. These would be
 centrally managed. Run through wireless. Somerset owns six but they are only used for
 training. Approximately \$300.00 each. Chromebooks are much easier to manage than Ipads.
 Debby Conrad will be looking for a committee to study Chromebooks and a possible grant
 application.

MLS EBook Project

The 3 vendors are Biblioboard, B&T Axis 360, and Proquest EBL. SAILS has agreed to load and maintain the catalog records. Estimated startup date is January 2015. MLS is offering webinar, Friday Sept. 5th 10:00 a.m.

New Business

<u>Electronic Resources- establishment of a study group to look at how catalog records are required and updated.</u> Debby and Kristen have been discussing this. Overlay cost is getting complicated. One click digital can overlay existing records. SAILS wants to change the way we are doing this. Overdrive has free marc records.

Fall River Historical Society Membership Inquiry
