## Committee reports-

<u>Pub Pac report</u>- Laurie Lessner discussed the ibistro interface and how online databases will be affected. We can't test. will send out to the committee on how to word it. Laurie will be putting the link regarding the museum passes on the SAILS sight.

## Personnel Committee report

Carol Julius made two recommendations regarding compensation for Debby Conrad. Deposit \$4000. into her retirement account, and give her an additional weeks vacation. Fy 07 MBLC – reimbursement for records. Money has increased. Due to resource sharing, they changed the proportions to make it more equitable for all libraries. We are getting closer to the 2001 figure received from the from MBLC. In 2001, Sails received \$300.000.Getting us closer to that figure. Final figure will be given to Debby by Friday.
