During the past 4 weeks we have been focused on improving the patron interface through updates in iBistro and evaluating the possibilities we have for moving to a Web 2.0 User Discovery platform. On February 23, we migrated to the latest version of iBistro now referred to as ELibrary. This is the first major software enhancement to our OPAC in several years and it includes more than just a new look and feel for patrons. Probably the most significant improvement is the inclusion of a "Did You Mean" feature. This is more than a spell check feature because it incorporates smart search suggestions based on usage of words and phrases. It also determines the context of a search term to provide intelligent search alternatives. To test the effectiveness of this service, we entered search terms that SAILS users had entered with zero results. We reentered the search terms and a significant number now offered the patron a did you mean option. A good example of how this is working is the patron looking for the movie Brokeback Mountain but s/he entered Breakback Mountain. The software now asks if the person meant Brokeback Mountain. This results in a higher success rate for searching which should also result in a more positive experience for the patron.

The My Account feature has been greatly enhanced. Patrons may now view where they are on the holds queue, a feature that has been requested for years. We have also added the ability to link to full details from titles listed under My Account. Patrons who have opted in may view past checkouts. Items listed under My Account tabs now include the Item Type Information.

While these are significant improvements, we are continuing to evaluate the next generation of User Discovery products to determine if they are appropriate for our users. On March 4th we invited 3 vendors to demonstrate their products to a group of staff members from SAILS' libraries. We are scheduling a series of focus groups to collect patron feedback on the options available to us. The Opac Selection Committee will be meeting in early April to review all of the vendor proposals and evaluations so that they can make a recommendation on what our next steps should be.

Kristin, Laurie and I have been attending Open Source Integrated Library System vendor demonstrations that are being conducted for representatives from all the networks in Massachusetts. CW/Mars, NOBLE, and MVLC have submitted an LSTA

grant to evaluate these products to determine their cost-effectiveness and usability. SAILS does not intent to migrate to another software package but we are participating as advisors on the project.

I attended the Massachusetts Library Trustees Symposium on March 7 in Boxborough. While there I met several people from SAILS libraries. I also had an opportunity to discuss library funding and the future of library networks with a commissioner from the MBLC. The theme of the meeting was funding and there were speakers from several libraries discussing fundraising and establishing library foundations. It was very interesting to talk to trustees about their concerns and to give them an overview of how networks function.

On March 18th I represented library networks in the annual House Ways and Means Hearing on the Massachusetts Board of Library Commissioners budget request. On March 23rd seven people from SAILS attended a one day statewide planning meeting to discuss the future of how service is provided to libraries in Massachusetts. Laurie, Kristin and I are also participating in various statewide delivery study committees. Combined with Kristin's participation on the Digital Commonwealth's Executive Board, and Laurie's membership on the MLA board the SAILS libraries are well represented at the statewide level.

During the month of April we will be finalizing our plans for the enhancements to the patron interface, steps we are taking to ensure the confidentiality of patron information, and moves we are taking to reduce printing and postage costs in FY10. We have also installed a software patch that fixed the problem of suspended holds appearing on the RHA.

Please feel free to take a look and play with the different implementations. The OPAC Selection Committee is meeting early in April to discuss the results from the focus groups, last month's vendor demos, and the original patron survey. We'll put it all together and see what our next step will be. Stay tuned!
