

Executive Director's Report

There have been many changes in the SAILS office recently and we are all very busy working on various projects. Steve Wilson left and at the same time Bob Demanche joined the office as Member Services
Librarian. The office departments have been reorganized so that Bob and Jorj now report to Laurie and all work in the Electronic Services
Department. We are contracting with Lantel to perform the VPN cutover project for the schools. This was originally been something we were going to handle in house. We are also accepting proposals from vendors to provide remote support for the 3 Windows 2003 servers hosted by SAILS (Webserver, Email Server, in-house file sharing Server). Laurie is taking over the management of the SirsiDynix server with some assistance from me. Bob is taking over some of the service requests that had been handled in the past by Laurie or Debby.

The Cataloging Services Department attending a Distance Learning Webinar about using the Java Client for Technical Services after which they began using that client exclusively. They are also working on updating the cataloging checklists for the libraries and dealing with the ever increasing variety of media formats. Kristin was selected to participate in the 2007 Massachusetts Library Leadership Conference and she will also be serving on the SEMLS Digital Archives advisory Committee.

Despite the departure of Steve, we are proceeding with our plans for the network telecommunications equipment upgrade. Verizon began work at the central site the week of January 15. Once all that work is done a final schedule for installing equipment will be established. We expect that libraries that are just receiving new equipment will begin to receive the new units on February 1. Orders for the new data lines have been submitted and right now the new service dates are to be the first week of March. As originally planned, the majority of the work should be completed by early March. The 2007-2008 Erate application has been filed for the bulk of the network's telecommunications costs. Kristin and I will be attending the annual Unicorn Users Group meeting in Colorado Springs so we will be short staffed for one week. The staff in the office continue to work with the new Unicorn client and we will be looking for volunteers to begin working with it in mid-March.

Kristin has been selected one out of fifty in MA to participate in Library Leadership Massachusetts 2007, sponsored by the Massachusetts Board of Library Commissioners and the six Massachusetts Regional Library Systems. The 3.5-day Institute drew applications from a highly-qualified pool of candidates from across the state and included professional staff and para-librarians from all types of libraries. Successful applicants had fewer than ten years in their fields. The Institute will create a structure for continuing supportive relationships among its participants. In exchange, graduates will play a role in advocacy efforts for Massachusetts libraries through professional organizations and/or contributions to publications or newsletters.

Zangwill Appointed to the Board



Irving H. Zangwill of Fall River was appointed to a two-year term on the nine-member Massachusetts Board of Library Commissioners in late December by former Governor Mitt Romney. He replaces Commissioner John Arnold who was first appointed in 1994 and whose terms of service had expired.

"As a child, seeing my mother stay up half the night reading and going to work in the morning, as well as being read to night after night by my father, the tone for my love of reading was set. Through the years, I continued this passion and as a teacher worked

to encourage it in my students," said Zangwill. "Having served as the Chairman of the Fall River Public Library Board of Trustees for many years, as well as serving on many other library organization and committees, I am absolutely delighted to have the opportunity of being a commissioner on the Massachusetts Board of Library Commissioner. I look forward to representing Southeastern Massachusetts in a way that will better it's library services and improve opportunities for its citizens."

A lifelong resident of Fall River, Zangwill was a teacher in the Fall River Public Schools for more than 30 years. He has served as the Chairman of the Board of Trustees of the Fall River Public Library since 1996, as well as the President of the Fall River Public Library Foundation since 2000. Among his other library appointments have been the President and Vice-President of the Massachusetts Library Trustees Association, and on the board of the Southeastern Massachusetts Regional Library System. In addition, he has worked with the MBLC on the Massachusetts Public Library Initiative, Trustee Handbook Committee and the State Advisory Council on Libraries.

Zangwill has a Certificate of Advanced Graduate Studies in Education from Boston University, a M.Ed. in Education from Bridgewater State College, and his B.A. in Psychology from UMass/Dartmouth.

Board to Restore Budget Cuts

"We are delighted that Governor Deval Patrick has restored the more than \$1 million in 9C cuts made by former Governor Mitt Romney in November," said Dr. Em Claire Knowles, Chair. "With our state funding now restored to its original budget for FY2007, it is anticipated that the full Board will be reversing its recent action that authorized the use of approximately \$280,000 from its Special Priorities and Projects Budget to make up the shortfall for online resources that had already been committed," she continued.

In addition, cuts to the nine automated networks that tie libraries together and support their catalogues and interlibrary loan efforts, and the subsidy to statewide delivery and funds intended to help small libraries join automated networks can be restored, said Robert C. Maier, Director. Also, by restoring the funding cut from the Talking Book Programs at the Perkins School for the Blind and the Worcester Public Library they will be able to continue their outreach and library service to the visually-impaired citizens of the Commonwealth. Members of the Board, along with the Massachusetts Library Association, will now be working with the new Legislature and Administration to continue providing funding for adequate library service in the upcoming FY2008 Budget. ~ David Gray, **MBLC**

There is no shipping and handling. This would be purchased through the Statewide contract. We are updating the process for ordering through us. We are asking you to tell us what the intention of the pc will be. For example, if it's going to be designated as a circ pc, we'll know to load Workflows and other appropriate software, assuming you're on PC Support. If you're not on PC Support, you may still purchase through us. Either way, if you request installation, there is a \$30 fee.
