**Blue Cloud Circ Pilot Project** – This will begin testing at one of our smaller schools.

Blue Cloud Cataloging - This will begin testing at Dighton Rehoboth Regional School District.

**Erate Application** – SAILS should be notified of approval in the next wave of funding. Things are still being worked out with Comcast.

**Novelist** – Enterprise links should be tested out by the libraries. There is possibly be one more training for directors and schools. This is a great tool that is being underutilized.
